- 3. Detail of employees be also included (other than residential units).
- 4. To be fill in block letters.
- 5. Resident without registration of servant / guard / tenants shall not be entertained for any svcs in DHA and CBC.
- 6. Violation of Sindh Govt orders, Police will file case against the defaulters.
- 7. In case of any change in guards or servants the owner / resident of the house to intimate within 3 (three) days.
